## Known Issues VIMS v5.16.12.8

HDAB-477	Yes	Create Order, Reconciliation and Search/Add page will not submit if User includes spaces after dose number value.	User receives message to remove spaces before submitting an order, reconciliation or adding a new lot number through the Search/Add page.	Submitting of the given page responds with an <i>“Invalid field value”</i> or <i>“Order Qty must be a positive integer”</i> error message and does not allow the User to proceed when the given page contains spaces. If this error is received, User should review entries to remove spaces after entries.
HDAB-480	Yes	Rejection reason on transfer print out does not include the rejection reason. Only says “Doses rejected by provider”.	Printable documents match the information on the screen.	User can view the rejection reason in the Transfer Detail screen prior to deleting the transfer. Rejected transfer documents are not usually printed.
HDAB-488	Yes	Order not decremented during high traffic usage and subsequently affects inventory lot logs.	Orders decrement from the lot logs correctly.	No work around.
HDAB-499	No	Search/Add page allows Users with Cold Storage Locations active to add less quantity to lot sets than is actually available.	An error message would show if the total quantity on hand does not match the total quantity in locations.	No work around.
HDAB-500	Yes	When a vaccine is removed from the Vaccine Return screen the Lot log entry lists the incorrect date.	The date either indicates the date the product was removed from listing OR spoiled/expired/recalled from inventory.	No work around.
HDAB-505	No	Allocation of lot numbers are determined by the total doses in the PVD instead of doses available in non-excluded pick locations.	Pick rules are followed according to available dose numbers per pick location & not total doses in the Depot.	No work around.
HDAB-510	No	Vaccine Location Report is unavailable in the Preproduction environment.	The Vaccine Location Report can be accessed in all environments.	No work around.

## Fixes in v5.16.12.8

### HDAB-383 – Picklist Formatting Error – Large space in middle of picklist (PVD only)

**Reported by:** PVD

**Version Reported in:** VIMS v5.16.12.2 or earlier

**Description:** When the pick list is printed in the “Approve Order” screen there is a large gap in the pick list.

**Resolution:** The pick list uses as few pages as possible when printing landscape style orders.

### HDAB-407 – Submit Reconciliation with No Inventory

**Reported by:** AHS/PVD

**Version Reported in:** VIMS v5.16.12.2

**Description:** When a Facility has no inventory, they are unable to submit an order, as the “Inventory Last Submitted” date does not update, and automatically redirects them back to the Reconciliation page.

**Resolution:** A Facility has the ability to place an order when there is no inventory listed and the “Inventory Last Submitted” date updates appropriately.

### HDAB-435 – More doses decremented than doses available when a lot change occurred, creating negative inventory

**Reported by:** AHS/PVD

**Version Reported in:** VIMS v5.16.12.2

**Description:** When a lot change occurs more doses decrement than are available for picking, creating negative inventory.

**Resolution:** Doses decrement correctly when an order is filled with multiple lots and negative inventory is not created. Related to HDAB-509.

## HDAB-495 – Instructions entered on AHS Depot orders transfer to subsequent Facility orders

**Reported by:** PVD/AHS

**Version Reported in:** VIMS v5.16.12.2

**Description:** When instructions are added to an AHS Depot order for the PVD, the instructions carry over to the AHS Depot Facility Users on subsequent orders even though the AHS/PVD order has been completely processed and the instructions no longer apply.

**Resolution:** Instructions added to a Depot order no longer carry forward & show up on subsequent orders placed by Facilities under that Depot.

## HDAB-498 – When a transfer is rejected, the lot log entry is incorrect for the shipper of the transfer

**Reported by:** PVD

**Version Reported in:** VIMS v5.16.12.7

**Description:** When a transfer is partially/fully rejected the entry in the lot log lists an incorrect order number.

**Resolution:** An order number assigned to a transfer, and any rejected doses for that transfer, will only be listed when the transfer is in progress. Once the transfer is complete, there is no transfer order number listed in the lot logs related to the transferred products.

## HDAB-507 – The Manufacturer on the picklist differs from the packing slip for the same product (PVD only)

**Reported by:** PVD

**Version Reported in:** VIMS v5.16.12.7

**Description:** When printing the pick list & packing slip for an order different Manufacturer's were listed for Meningococcal B & Meningococcal C Conjugate products.

**Resolution:** All Manufacturer information is now sourced from the Lot Details page.

## **HDAB-509 – When the PVD submits an order for a Depot, more doses will be shipped than are available for picking in non-excluded pick locations (PVD only)**

**Reported by:** PVD

**Version Reported in:** VIMS v5.16.12.7

**Description:** When the PVD places an order for a Depot, and puts it through the Approve & Print process, the order will be filled automatically using inventory from excluded pick locations, instead of going into back order.

**Resolution:** Only doses available for picking (in non-excluded pick locations) decrement from inventory and a back order is created when processing a Depot order created at the PVD.
